When operated under the specified test conditions (room temperature: 22 °C ± 0.5 °C; relative humidity: 45 % ± 5 %), the screwdriver ETD M08 ABL V2 in combination with controller and power supply is suitable for use in cleanrooms fulfilling the specifications of the following Air Cleanliness Classes according to ISO 14644-1:
